i visited with 3 young children today. We thoroughly enjoyed the ballet show of goldilocks and the new earthquake house and surrounding area. It has been redone very nicely and the children loved it.

However the children were distressed when we walked through the area displaying the huge screens of photos by Lemi Ponifasio. It was a large open area and we were exploring the museum. On the screens were photos of people walking through some trees. Very innocent. I did not observe any sign giving a warning of inappropriate content. The children saw a table in the centre where people could draw or write on a piece of paper. As they did this the photo changed to one of a naked women covered in blood. This was completely unexpected and myself and the children were very distressed.

When I left the area I commented to a te papa person I saw and he pointed to a very very small sentence on a white stand (which I couldn't actually read from a couple of metres away). He said it gave some sort of warning.

I feel this is not appropriate warning for people that they are entering an exhibit with such explicit content. I would expect a large sign with a stop sign or warning sign in large red writing or similar.

I observed another flustered mother trying to stop her around 12 year old son from viewing the images. I trust that you will be able to rectify this and display large clear signage warning people of explicit content prior to entering the exhibit area.

Hi there.

I've always love visiting Te Papa particularly with my kids, its been a fabulous experience for all ages each time we visit, I've always felt safe in letting my kids see and explore.

However I recently visited during the school holidays and to my shock I accidentally had my kids see (2 story high) full frontal male and female nudity in the your exhibition "MAU: House of Night and Day". I missed the sign's and being that Te papa was particularly full of young families I didn't think such a large exhibition would be viewable front and centre of the exhibition space. There weren't signs at the area we exited and we weren't able to find a way back out to the main corridor without seeing it from above and the side again!

We'd had a fantastic arvo and then this left my 13 year old daughter and 9 year old son feeling sick, upset and disturbed (their words) and me feeling extremely upset and angry! As we left another family was entering and we gave them a warning, the dad looked up at large male genitalia and quickly moved his young daughter (approx 7) and wife away from the exhibition.

I have an arts background and am very open minded about art and the human form but as a parent this breached common decency and I imagine some public exposure laws especially for under age children. In my mind I would have thought this be in a "doored" very well signed area and not the main open, usually very public, free flowing art area.

Sadly I now have such a different feeling about have family days at Te Papa the trust has definitely been tested, can I as a parent safely visit with my young ones or is this the new norm?

I wanted to provide some feedback about a traumatising experience I had today at Te Papa.

We visited with our 3 1/2 yr old son and 6 month old son. As we had a stroller we took the lift up to Level 5 (the directory had mentioned there was an area for Kids).

Upon exiting the lift my son went straight around the corner and on to the overbridge to get to the colour. There he was confronted with an enormous video of a naked man having his genitals tortured (?). I tried to whip him away as fast as possible but he was a bit distressed and unsure of the image.

I was quite shaken too, it made me feel like I had failed as a parent for not anticipating that kind of graphic image was going to be at Te Papa (on the way to a Kids area no less). I did see a sign on the actual bridge

about nudity... but really a bit late once they have already turned the corner! Plus there is nudity and then there is what we saw....

When we were through the other side I did ask one of your staff if there was a way to exit avoiding that bridge when exiting. She told me that was the only access with the pram and that the image of the man was a 40 second section of a 40 min loop. So that was some almighty bad timing.

But we shouldn't have really had to go through that.

I absolutely respect the right of the artist to express themselves however they see fit. But should that particular work really be positioned in the main pram route to a children's section? It should be in a space where adults can opt in to view it. I felt that myself and my son didn't get to opt in.

Or, alternatively could a staff member be near the lift and able to stop families with young children if that section of the film is playing?

I'm still worried about what enduring effect that experience will have on my son so I just wanted to let you know and perhaps reconsider where or how you share this work.
